**JOINT NOTICE OF SETTLEMENT**

Plaintiff, individually and as representative of a proposed Settlement Class (collectively, “Plaintiffs”), and Defendant BancorpSouth Bank (“BancorpSouth Bank”) (Plaintiffs and BancorpSouth Bank are collectively referred to as the “Parties”), through their respective undersigned counsel, notify the Court that on January 5, 2016, they executed a Summary Agreement that sets forth the material terms of the Parties’ binding and enforceable agreement to fully, finally and forever resolve, discharge, and release all rights and claims that were or could possibly have been claimed, raised, or alleged in the above referenced action based on BancorpSouth Bank’s payment of the sum of Twenty-Four Million and 00/100 Dollars (\$24,000,000) (the “Settlement”), without admission of liability by BancorpSouth Bank, subject to preliminary and final approval of the Settlement pursuant to Fed. R. Civ. P. 23, and dismissal of the action with prejudice by the Court. The Settlement will be memorialized in a comprehensive written Settlement Agreement and related documents, which the parties will file

with the Court as part of a motion for preliminary approval as soon as practical with a goal of filing by January 29, 2016.

Based on the foregoing, the Parties respectfully request that the Court temporarily suspend all further proceedings, pending the filing of the proposed Settlement Agreement. A proposed Order is attached.
